

2257 / AI-Generated Adult Content Compliance Statement



This 2257 / AI-Generated Adult Content Compliance Statement applies to SENS Platform, operated by SENS LTD, a company incorporated under the laws of Seychelles with registration number 239563 and registered office at Suite 1, Second Floor, Sound and Vision House, Francis Rachel Street, Victoria, Mahe, Seychelles.

SENS Platform is an adult-oriented digital platform intended strictly for persons who are at least eighteen (18) years of age or have reached the legal age required to access adult-oriented content in their jurisdiction, whichever is higher.

Platform Content may include adult-oriented, sexually explicit, AI-generated, synthetic, fictional, digitally created, digitally modified, or otherwise generated content. Unless expressly stated otherwise, Platform Content does not depict real human performers, real persons, actual sexual conduct involving real persons, actual relationships, or real events.

Because Platform Content is intended to consist of AI-generated, synthetic, fictional, digitally created, or otherwise non-real content and does not depict actual human performers unless expressly stated otherwise, SENS LTD does not currently maintain performer records of the type maintained for visual depictions involving real human performers.

SENS LTD maintains a strict zero-tolerance policy prohibiting any content involving minors, child sexual abuse material, child sexual exploitation, grooming, sexualized depictions or implications involving minors, non-consensual intimate content, unauthorized sexual deepfakes, exploitation, trafficking-related content, coercive content, revenge pornography, hidden-camera content, or any content suggesting lack of consent.

SENS LTD also prohibits content that uses, imitates, reproduces, or exploits the name, image, likeness, voice, biometric features, identity, persona, or recognizable characteristics of any real person without appropriate authorization.

SENS LTD uses automated systems, artificial intelligence safety tools, moderation technologies, human review processes, reporting mechanisms, compliance procedures, and other technical and organizational measures to prevent, detect, restrict, remove, or report prohibited content.

If any content made available through Platform is or becomes subject to the record-keeping requirements of 18 U.S.C. § 2257, 18 U.S.C. § 2257A, or 28 C.F.R. Part 75, SENS LTD will require that all applicable age-verification, identity-verification, consent, performer, producer, and compliance records are created,

maintained, and made available by SENS LTD, the relevant producer, licensor, contractor, partner, or designated custodian of records, as applicable, before such content is made available through Platform.

SENS LTD will not knowingly publish, distribute, display, or make available content depicting actual human performers engaged in sexually explicit conduct unless SENS LTD determines that appropriate age-verification, identity-verification, consent, licensing, distribution rights, and applicable 2257 / 2257A record-keeping documentation are in place.

For content produced, commissioned, licensed, supplied, or otherwise provided by third-party producers, licensors, contractors, partners, or other authorized content sources, SENS LTD may rely on contractual representations, warranties, licenses, compliance certificates, consent confirmations, age-verification confirmations, identity-verification confirmations, and custodian-of-records information provided by such parties.

SENS LTD reserves the right to request, review, verify, remove, restrict, suspend, or disable access to any content where SENS LTD determines or reasonably suspects that required records, warranties, age-verification materials, consent records, licenses, permissions, or other compliance documentation are missing, inaccurate, incomplete, unreliable, or insufficient.
